1. MEETING CALLED TO ORDER BY THE MAYOR

NOTICE OF PUBLIC HEARING

Councilman Jenkins made a motion, which was seconded by Councilmember Jordan and passed unanimously, that Council adopt the following budget resolution:

(2) Memo 18-16 – Parks and Recreation Department – Master Plan

Councilman Woodard made a motion, which was seconded by Councilman Jenkins and passed unanimously, that Council authorize staff to enter into contract discussions with WithersRavenel. A bid tabulation is listed below:

(3) Memo 18-17 – Braswell and M.A. Ray Center Hours

Councilman Taylor made a motion, which was seconded by Councilmember Bynum and passed unanimously, that Council authorize staff to temporarily alter the schedules at Braswell and M.A. Ray Recreational Centers to evaluate providing permanent Sunday hours. The schedule is attached at page 73-74a.

(4) Memo 18-18 – NCEMPA BOC – 2nd Alternate Commissioner

Councilman Shephard made a motion, which was seconded by Councilman Jenkins and passed unanimously, that Council appoint Brian Mustard, Electric Utility Director to serve as second alternate commissioner representing the Town of Tarboro on the North Carolina Eastern Municipal Power Agency Board of Commissioners.

B. Town Attorney

Chad Hinton informed Council that he recently attended the Municipal Attorney's Conference at the UNC School of Government.

C. Council Members

Ward 1 – Councilman Woodard – requested Council and staff be mindful of the lack of diversity within Town staff, he suggested a diversity plan to assist in evening staff members.

Ward 2 - Councilman Taylor – asked if businesses affected by the windblown sign ordinance had been notified and if they had obtained a permit. Councilman Taylor also asked for clarification on the tour for the ordinance updates.

Ward 3 – Councilman Burnette – expressed concerns regarding Council appointed committee members not attending meetings. He was informed that Council could replace committee members at anytime.

Ward 4 – Councilman Brown – requested an update on the Verizon cellular tower, no update was provided at this time.

Ward 5 – Councilman Jenkins – None.

Ward 6 – Councilmember Jordan – expressed concerns about parking around the church on the corner of Main Street and Granville Street. Councilmember Jordan requested an exception be made for the pastor to avoid receiving parking tickets.

Ward 7 – Councilmember Bynum – None.

Ward 8 - Councilman Shephard – requested insurance funds be listed separately on the financial report provided monthly to Councilmembers and asked for an update on negotiations with

Edgecombe County Public Schools and the Town on upkeep at Municipal Stadium.
